

**MINUTES OF THE MEETING OF SHAWBURY PARISH  
COUNCIL HELD IN THE VILLAGE HALL ON TUESDAY  
DECEMBER 14<sup>TH</sup>. 2010 at 7.00pm.**

**Public Session:**

No members of the public were in attendance and no issues were raised.

---

Prior to the start of the meeting the Clerk informed Members that he had received a resignation letter from Simon Jones. He feels unable to continue because of the amount of work generated as a Cabinet member of Shropshire Council. He would attend Parish Council meetings as often as possible in his role of Shropshire Councillor.

Clerk had discussed the resignation with the Returning Officer and it had been agreed to advertise the vacancy early in the New Year.

**10/147 Apologies:**

Apologies were received and accepted from Mrs. F. Medley, Mr. S. Jones, Mr. R. Pinches, Mr. R. Bailey and MACR G. Longmuir (RAF Shawbury)

**10/148 Declaration of Personal or Prejudicial Interests:**

No declarations were made.

**10/149 Minutes of Meeting held on November 9<sup>th</sup>. 2010:**

The minutes of the meeting, having been circulated, were approved and signed by the Chairman as a true record.

**10/150 Matters Arising:**

**(a)Highways (10/138(a)).**

David Limb (Highways Engineer) had promised to take action over the problems raised. The only action taken so far was the repair to the pothole in Whitelodge Park but the work was so poor that by the end of the day all the material used had become loose again. Clerk has reported this to the Highways Engineer.

**(b) Application for grant aid for Cycle Track (10/129(2))**

Clerk reported that he had spoken to the Youth Officer and he had stated that he hoped to get approval during the school Christmas holidays.

(c) Toilet Facilities (10/129(6)):

Mr. Houlihan had contacted the Clerk and advised him that he had total responsibility for all aspects of the Elephant & Castle Public House. Modernisation of the pub had taken place before the requirement to provide disabled toilet facilities and there were no plans to install any. No reply had been received from the Parochial Church Council.

It was decided to take no action at present and to review the situation in the New Year.

(d) Burial Ground (10/129(8)):

A copy of the Council's regulations had been sent to the Vicar with a request that they were issued to the relatives/representatives of anyone being buried in the Council Burial Ground. Clerk thanked all those who had suggested modifications to the letter being sent to the relatives of those already buried there and the Chairman confirmed that she would sign the letters and deliver them in the New Year.

(e) Village Design Statement (10/113)

As Mr. Brown was not in attendance for this item it was decided to postpone discussion until the next meeting.

(f) CCTV (10/136)).

There had been no response from Mr. Paul Clarke or Mr. Dave Roberts regarding the possibility of Mr. Dodd and Mrs Medley checking that the system was working.

The library service was hopeful that arrangements could be made to access the Shawbury Library broadband but there were central government constraints that needed to be clarified.

(g) Additional grant from English Heritage (10/129 (9))

English Heritage had agreed to an annual payment of £420 to cover the cost of cutting the grass and surrounding paths in the Moat.

(h) Poynton Road Hedge (10/134)):

Shropshire Council had advised the Clerk that as the hedge was not on agricultural land and providing the replacement fence was less than 1m in height there was no requirement for planning approval. Members decided that there were a number of issues to be resolved and any decision on possible action was deferred to the next meeting.

(i) Drop in Centre (10/134)

Clerk reported that he had written to the Village Hall Committee offering a grant to set up a drop in centre. To date no response had been received.

(j) Simon's Garage (10/134)

Mr. Bailey had met with Mr. Reader, the owner, to discuss re-positioning the sign but the issue had yet to be resolved.

(k) Vehicle operated speed signs (10/129(5)).

Mr. Jones had sent a written report stating that Shropshire Council was in the process of reviewing the funding arrangements and he would pass on the details when they had been finalised.

(l) Sparrow Cottage.

Shropshire Council has issued an Enforcement Order requiring the site to be cleared by December 20<sup>th</sup>. An appeal was anticipated and the Parish Council would be given the opportunity to respond.

(m) Mr. Jamie – Tree work:

Clerk had written to Mr. Jamie asking for confirmation that he was going to complete the remedial work on the trees in the near future but no response had been received. Mr. Brown agreed to take some action.

(n) Circulated Parish Plan report (10/133)

Clerk confirmed that the report had been sent to the Local Press, Radio Shropshire and the Prime Minister. A number of copies had been left in the Library and the Village Hall. The only response had been from the Prime Minister '*thanking the Council for sharing their views with him*'.

**10/151 Correspondence:**

A complaint had been received about anti-social behaviour at the sites of the Play Area and Youth Pod and that no action had been taken regarding the planting of trees between the play area and the houses on the Glebelands. Clerk was asked to identify how many trees were required. The trees held by Mr. Bailey could be planted and efforts would be made to secure some additional ones if necessary.
4. Shrewsbury and Telford Hospital – 'A Healthier Future.'
5. Playing Fields Association – 'The Playing Field'.
6. Shropshire Council – Draft Supplementary Planning Document – consultation document. Agenda item for next meeting.
7. Peoples Post Code Trust. Clerk to check what grants were available for Parish Councils.

**10/153 Financial Statement:**

**10/154 Budget and Precept Setting 2011-2012:**

**10//155 The Youth Pod:**

Mr. Bailey had sent a report of a discussion he had held with Sue Thomas regarding the possibility of a grant from the Community Safety Partnership to cover repair costs. Clerk to follow this up and seek a quotation from the suppliers of the Pod for replacing acrylic windows with black metal sheet.

**10/156 The Glebe:**

Members considered a report from Mr. Bailey regarding a meeting with Mr. Hughes (Shropshire Wildlife Trust). It was agreed that there were a number of interesting and exciting suggestions. However no progress could be made until the Diocese had confirmed the lease for the area. Clerk to contact Mr. Watney to check the progress of the scheme.
